



Step-by-Step Registration Guide

If you do not already have an account on Clubspot, you will be prompted to make an account the first time you access the registration site. To begin the registration process, you select either an existing participant or “New Participant” from the list

1) Membership Status

A discount is available to Sagamore Yacht Club members. To obtain this discount, members should indicate they are Sagamore YC members and enter their membership number. Note that program fees cannot be billed or collected through an SYC account. All program fees are billed through Sagamore Junior Sailing using the registration portal.

2) Select Class and Add Sessions

Two classes are offered:

Opti Class - The optimist class is aimed at sailors 8 to 12 years old but can accommodate sailors as old as 15 who are focused on Opti competition. Sailors in this class will primarily be sailing solo in optimists. In some cases older and/or more experienced sailors might also spend some time sailing and getting familiar with the Feva. This class will be further divided up into beginner and intermediate/advanced groups as appropriate for both on and off water instruction.

Feva/420 Class - This class is for sailors 11 to 18 years old. Sailors in this class will primarily be sailing double handed in Fevas or 420s. This class will be further divided up into different skill groups as appropriate for both on and off water instruction. Note: to compete in JSA regattas Feva sailors must be 12 and have a minimum combined crew weight of 180 lbs and 420 sailors must be 14 and have a minimum combined crew weight of 220 lbs.



I, the undersigned, am a parent or person having legal custody of the above listed Minor. I wish to voluntarily enroll the Minor in the Sagamore Junior Sailing Corp. (SJS) Program (the Program). In consideration of the Minor's participation in this voluntary recreational activity, I acknowledge and agree as follows, for myself, the Minor and the Minor's heirs, representatives and assigns:

1. I represent that the Minor is in good health, is able to safely undertake sailing activities, is a competent and confident swimmer and is(are) capable of comprehending instruction, following directions and observing proper safety precautions. I agree to abide by the decisions of the Program's Head instructor if he/she finds it necessary to place limitations on the minor's activities in the program as a result of the minor's lack of attention, misbehavior or failure to follow safety precautions.

2. I understand that risks exist in the Program activities and I will maintain insurance as prudent for the protection of the Minor and myself, including medical and liability coverage.

3. For the purpose of the Agreement, "SJS includes the directors, officers, employees, agents, and committee persons of Sagamore Junior Sailing Corp. This Agreement contains all of the understandings between the undersigned and SJS regarding the subject matter hereof and may be modified only in writing signed by the parties. The undersigned Parent/Guardian has not relied upon any promise, representation or inducement not contained herein. The provisions of this Agreement shall be interpreted in such a way so as to render them valid whenever possible, and any ambiguity shall not be strictly construed against SJS. If any part of this Agreement is held invalid by a court or arbitrator having jurisdiction, the remainder shall continue in full force and effect.
